## RE: Mobile Medical Vehicle (New, Stock, Preowned or Refurbished) RFP

For the benefit of all prospective Vendors submitting a response to the **Mobile Medical Vehicle** (New, Stock, **Preowned or Refurbished**) **RFP** and to avoid possible confusion, the RFP documents are clarified as follows. Please note this Letter of Clarification # 1 and all attachments are hereby incorporated into the Request for Proposal document and shall supersede any previous specification or provision.

1. Question: Is Accucold the brand name of the fridge?

Answer: Yes, see response to question # 8.

2. Question: Does the Unit need to be ADA Complaint entrance?

**Answer:** Yes, see page 11 of Mobile Medical Vehicle (New, Stock, Preowned or Refurbished) RFP. The descriptions and Internal Options are examples; therefore, you have latitude to modify as needed and You can offer different models and frameworks that would be associated with different price points. Substitutions can be proposed as alternatives if they cover the specifications outlined in the document all alternatives in the Deviation Page, see page 28.

**3. Question:** As a non-publicly traded company, financial statements are not available. Additionally, professional ethics forbid a CPA firm from providing a letter of financial solvency. Will a bid that does not include these disclosures be acceptable?

Answer: Provide any form of proof of Financial Solvency and/or ability to fill this requirement.

4. Question: It is understood that a 120-day irrevocable offer is requested. However, will SURCHARGES be acceptable? In so far as the Buyer acknowledges the economic uncertainty relating to supply chains, energy resources, and fuel and freight costs existing at the time of the execution of this agreement. As such, Buyer acknowledges and understands that, from time to time, suppliers and/or manufacturers that supply products or equipment to Seller may apply certain surcharges and/or additional costs on orders. In the event that Seller's suppliers apply such surcharges and/or additional costs, Seller may, in its sole and absolute discretion, pass such surcharges and/or additional costs through to Buyer at the equivalent amount or rate as such surcharges and/or additional costs are charged to Seller

**Answer:** No, any change in the Vendor "Offer Price" subsequent to the close of the RFP will be considered as a change in pricing thus making the "offer" unfixed and non-final.

5. Question: Are blanket deviations from the body equipment acceptable

**Answer:** Yes, see page 11 of Mobile Medical Vehicle (New, Stock, Preowned or Refurbished) RFP. The descriptions and Internal Options are examples; therefore, you have latitude to modify as needed and you can offer different models and frameworks that would be associated with different price points. 6. Question: Are blanket deviations from the internal options acceptable?

**Answer:** Yes, see page 11 of Mobile Medical Vehicle (New, Stock, Preowned or Refurbished) RFP. The descriptions and Internal Options are examples; therefore, you have latitude to modify as needed and You can offer different models and frameworks that would be associated with different price points. **7. Question:** In lieu of open-ended additional training for 30 days from delivery, is one additional training within the 30-day from delivery timeframe acceptable?

Answer: Yes

8. Question: Do you have the model number for the fridge?

**Answer:** No, Pharmacy-grade refrigerator and freezer space for medication (refrigerator temp:  $36^{\circ} - 47^{\circ}$ , freezer temp:  $0^{\circ}$  and below and need medical grade adjustable thermometers.

This Letter of Clarification #1 is hereby incorporated in the Proposal document and shall supersede any previous specification or provision in conflict with the Letter of Clarification #1. All prospective participants are directed to respond accordingly. Vendors are required to add this Letter of Clarification #1 to the original Proposal document.
