Introduction

The Harris Center's Dual Diagnosis Residential Program is a 138-bed integrated residential treatment unit for male and female felony probationers. We use an evidence-based model for addressing mental health, substance abuse and criminality in a highly structured environment that focuses on psychiatric and medical stabilization, pro-social lifestyles and cognitive behavior treatment. This report contains PREA Annual Reporting data from year 2023 and reflects our commitment to compliance with the standards.

Policy Statement

The Harris Center maintains a zerotolerance standard for sexual misconduct in any correctional or community-based facility where operations are located.

Summary

The Harris Center upholds a strict zero tolerance policy for sexual misconduct. Our commitment to implementing the PREA is a top priority, ensuring a culture of safety and prevention. We encourage internal reporting to identify and mitigate risks, supporting ongoing compliance with PREA standards.

Each incident is thoroughly investigated according to PREA Standards and reviewed with a dedicated team. We continue to rely on our county partners, including law enforcement and community health centers to help resolve issues and prevent future incidents.

Our training and documentation cover prevention, to ensure all measures possible are taken to prevent opportunities for PREA related occurrences.
